NHRC ACCREDITATION STATUS FACES REVIEW IN GENEVA THIS WEEK

CONTEXT: The National Human Rights Commission (NHRC) of India faces a crucial review in Geneva this week, where its accreditation status, particularly its "A status," is under scrutiny due to concerns about its composition, investigative procedures, and representation of gender and minority groups.



NHRC ACCREDITATION REVIEW IN GENEVA

- The NHRC faces a crucial review in Geneva this week to defend its human rights processes.
- The decision on retaining the "A status" will impact its voting rights at the UN Human Rights Council and UNGA bodies.

Concerns Leading to Review

 NHRC's ratings were paused in 2023 due to issues like composition, police involvement in investigations, and lack of gender and minority representation.

Review Process

- The meeting of the GANHRI SCA on May 1 will determine NHRC's accreditation.
- The Ministry of External Affairs is engaging diplomatically to support NHRC's case.

Past Accreditation History

• India has faced a listing downgrade before, retaining "A ranking" in 2006 and 2011 but being deferred in 2016.

Issues Highlighted by SCA

• SCA criticized NHRC for police involvement, lack of pluralism, gender representation, and diversity in committee composition.

Stakeholder Perspectives

 Civil society groups and international bodies have raised concerns about human rights restrictions and discrimination in India, urging a reconsideration of NHRC's "A rating."

CONCLUSION: The NHRC of India is under review in Geneva for its "A status" accreditation, facing scrutiny over composition and investigative processes. Concerns include police involvement, lack of diversity, and representation issues. Civil society and international bodies advocate for reconsidering NHRC's rating amid human rights concerns

TURNOUT AND TROPES

CONTEXT: The voter turnout trends observed in the second phase of the general election, highlight variations across states and potential factors influencing voter participation, including past election outcomes, communal rhetoric, and party strategies, with implications for the ongoing election phases.



Voter Turnout Trends:

- Comparative analysis of the second phase of the general election shows varying turnout rates across states, with high turnout in the East and North East and lower turnout in Bihar and Uttar Pradesh.
- Lower turnout is also observed in Kerala, Madhya Pradesh, Maharashtra, and Rajasthan compared to 2019, prompting post-poll surveys to understand the reasons.

Factors Influencing Turnout:

- Heat-wave conditions in several states during the first phase have raised questions about their impact on voter participation.
- Voters' level of enthusiasm and engagement with the electoral process is being debated as a potential factor in lower turnout this time.

TOWARDS GREEN GROWTH

- Encourages collaboration between RBI and the Finance Ministry to establish a comprehensive green taxonomy reflective of India's diverse developmental paths.

- Appreciates initiatives like Sovereign Green Bonds issuance and expanding participation in green government securities.
- Emphasizes the need for a detailed assessment of climate change's economic and financial impacts, alongside administrative consultations for a robust green taxonomy.

Collaborative efforts, comprehensive assessments, and innovative measures are vital for steering India towards a resilient and green economic future.

The significance of carrier aviation

CONTEXT: INS Vikrant, India's first domestically built aircraft carrier, marks a milestone in its naval development.



India's first domestically built aircraft carrier, INS Vikrant, marks a leap in its naval power. The technical aspects and historical significance of Vikrant, along with its role in India's strategy to have a strong three-carrier fleet for regional dominance is an important aspect of India naval strategy in Indian Ocean and beyond. Experts have commented on global trends in carrier development and the ongoing debate between carriers and submarines in naval warfare.

THE GIST

The design work on the Indigenous Aircraft Carrier (IAC)-I, later christened Vikrant, began in 1999. One of the crucial decisions with respect to Vikrant was on the warship grade steel, which till then was procured from Russia. After much brainstorming, it was decided that it would be developed and produced in India.

Vikrant can operate an air wing of 30 aircraft comprising MiG-29K fighter jets, Kamov-31, MH-60R multi-role helicopters, in addition to indigenous Advanced Light Helicopters and Light Combat Aircraft (Navy).

The Navy has already moved a case for a second Indigenous Aircraft Carrier (IAC-II), a repeat of a Vikrant-like carrier.

Escalating Ethnic Conflict in Manipur

CONTEXT: In Manipur, the longstanding ethnic conflict between the valley-based Meitei community and the hills-based Kuki-Zo communities has once again erupted into violence. The recent events include fatal gunfights and attacks on security forces, highlighting the fragile security situation in the region.



Recent Incidents:

- **Gunfights:** In the early hours of Sunday, a clash along the Kangpokpi-Imphal West district boundary resulted in one death and three injuries. This incident follows a pattern of recurring violence between these communities.
- CRPF Camp Attack: Just within 24 hours prior, unidentified militants attacked a Central Reserve Police Force (CRPF) camp in Bishnupur district, killing two personnel and injuring two others.

Government Response: Manipur's Security Advisor, Kuldiep Singh, has vowed to take strong action against those responsible for the violence. Immediate security measures were deployed to quell the clashes and restore order.

Current Situation: The clashes involved exchanges of gunfire between groups from the valley and hill areas, prompting security operations to bring the situation under control. However, the exact origins of the violence remain unclear.

Impact and Fallout: As a result of the clashes, a shutdown was called in Kangpokpi district. The violence has not only claimed lives but has also led to widespread displacement and disruption in the affected areas.

Continued Unrest: Despite brief periods of calm, the ethnic conflict has persisted, claiming over 220 lives since its onset last year. The recent escalation underscores the ongoing challenges in achieving lasting peace and stability in Manipur.

INDIA'S CHINESE IMPORT BILL UP 2.3 TIMES IN 15 YEARS

CONTEXT: A report by the Global Trade Research Initiative highlights India's growing dependence on China for industrial goods, with a widening trade deficit and strategic concerns.

INDIA'S GROWING DEPENDENCE ON CHINA FOR INDUSTRIAL GOODS (GTRI REPORT)

• Sharp Increase in Imports:

- From \$70 billion in 2018-19 to \$101 billion in 2023-24.
- China's share of India's industrial goods imports rose from 21% to 30% over 15 years.

• Dominant Supplier Across Sectors:

- China is the top supplier in eight major industrial sectors, including machinery, chemicals, pharmaceuticals, and textiles.
- Almost 42% of India's textile and clothing imports come from China
- Similar dominance is seen in machinery (40%) and electronics (38.4%).

• Widening Trade Deficit:

- India's exports to China stagnated around \$16 billion annually.
- Imports surged, resulting in a cumulative trade deficit exceeding \$387 billion over six years.

Reliance Across Sectors:

- China is a major source for a wide range of Indian imports, with a significant share across various sectors:
- Textiles and clothing (42%)
- Machinery (40%)
- Electronics, telecom, and electrical products (38.4%)
- Chemicals and pharmaceuticals (29.2%)
- Plastics (25.8%)
- Automobiles (23.3%)

• Strategic Concerns:

- The report highlights the "profound" strategic implications of dependence on China.
- Concerns extend beyond economic risks to national security dimensions.

Indian Navy aids Panama tanker after Houthi attack

CONTEXT: The Indian Navy successfully guided a crude oil tanker under missile attack by Houthi militants to safety, ensuring the well-being of 30 crew members, including 22 Indians.



MAJOR POINTS

- Indian Navy guides Panama-flagged crude oil tanker, MV Andromeda Star, with 30 crew members, including 22 Indians, to safety.
- 2. The vessel was attacked by Houthi militants and responded to by Indian Navy destroyer INS Kochi on April 26.
- 3. All crew members of MV Andromeda Star were reported safe following the attack.
- The U.S. Central Command confirms militants launched three missiles near merchant vessels Maisha and Andromeda Star, resulting in minor damage to the latter.



INTERNATIONAL RELATIONS

Seizure of Pakistani Boat with Drugs off Gujarat Coast

CONTEXT: A collaborative operation between the Gujarat Anti-Terrorist Squad (ATS) and the Narcotics Control Bureau (NCB) resulted in the seizure of a Pakistani boat carrying 14 crew members and 86 kg of drugs worth ₹602 crore off the Porbandar coast in Gujarat.



Details of the Operation:

- **Seizure:** The authorities apprehended the entire crew of 14 individuals, all of whom are Pakistani nationals.
- Drug Consignment: The intercepted drugs were intended for delivery to unidentified handlers in Tamil Nadu, with a subsequent plan to smuggle them to Sri Lanka for final distribution.

Government Action: The Gujarat Director-General of Police, Vikas Sahai, has transferred the case to the NCB for further investigation into the drug smuggling network.

ISRAEL'S THREAT TO ATTACK RAFAH, ABBAS CALLS FOR US INTERVENTION, HAMAS RESPONSE FOR NEGOTIATIONS

CONTEXT: Concerned about the escalating tensions in Gaza, Palestinian President Mahmoud Abbas calls on the United States to prevent Israel from attacking Rafah. Hamas is set to respond to Israel's ceasefire proposal, while international efforts, including Egypt's mediation, aim to find a path toward lasting calm in the region.



1. Abbas Calls on US to Halt Attack on Rafah

- Palestinian President Mahmoud Abbas states that only the US can prevent Israel from attacking Rafah in Gaza.
- He emphasizes that the assault could lead to a significant displacement of the Palestinian population.
